User Agreement & Terms of Service

- 1 Orders must be paid for in full before items are prepped for delivery. Orders will not be accepted without payment.
- 2 Orders must be received outside of the 48 hour notice with payment in full to avoid the service fee. Orders received within the 48 hour timeframe or on site are based on availability and will incur the late order service fee.
- 3 A valid and authorized credit card must be on file (Visa, Mastercard, Discover, Amex).
- 4 In the event of returned checks or declined credit cards there will a \$75.00 service fee.
- 5 Propane will not be delivered without payment. Payments can be made using the online link to restore your service.
- 6 State & City Sales tax is added to all services supplied.
- 7 Vendor is not allowed to share propane with neighbors.
- 8 Customers are responsible to connect and disconnect propane tank(s).
- 9 Vendor is responsible to call for pickup service either to replace or final by the end of the event. Propane tank(s) must be disconnected.
- 10 All material and equipment used to provide service, is provided on a rental basis only and remains the property of CORT Party Rental. Equipment shall only be removed by CORT Party Rental personnel at close of show. Equipment removed by vendors will be charged to the card on file.
- 11 Propane will be delivered to the booth number provided. All other contact information is required to confirm an order.
- 12 Vendors are required to provide approved fire extinguishers and follow all safety standards required by the show producers and the City of Seattle.
- 13 Credit will not be provided for unused propane.
- 14 Signing this order vendor hereby agrees to all applicable terms of service.
