## User Agreement & Terms of Service

- 1 Advance orders must be paid for in full before installation can begin. Orders will not be accepted without payment.
- 2 Advance Orders must be received by the deadline date with payment in full to receive the discounted rate. Orders received after the deadline date or on site will be charged the late order rate.
- 3 A valid and authorized credit card must be on file (Visa, Mastercard, Discover, Amex).
- 4 In the event of returned checks or declined credit cards there will a \$75.00 service fee.
- 5 Electrical service will be turned off for lack of payment. Payments can be made using the online link to restore your service.
- 6 State & City Sales tax is added to all services supplied.
- 7 Vendor is not allowed to share power with neighbors.
- 8 All material and equipment used to provide temporary electrical service, is provided on a rental basis only and remains the property of CORT Pro Services. Equipment shall only be removed by CORT Pro Services personnel at close of show. Equipment removed by vendors will be charged to the card on file.
- 9 Outlets will be installed in one location at the back center of 10x10 booth space.
- 10 Labor is not included in the outlet rate to connect 208 volt equipment, special wiring or distributing outlets to multiple locations within any size booth space. There is a minimum one hour labor charge plus materials for booths that request outlets to be moved or distributed to multiple locations
- 11 Vendor equipment is required to comply with federal, state and local electrical codes. CORT Pro Services will not provide electrical service to equipment not in compliance with electrical codes.
- 12 Vendor holds harmless CORT Pro Services for any and all losses of power beyond CORT Pro Services control, including but not limited to, losses due to utility company failure, permanent power distribution failure, generator failure, power failure due to vandalism, vendors faulty equipment, circuit overloads caused by vendor, vendor equipment not compatible with GFCI receptacles.
- 13 Claims or adjustments will not be considered unless filed in writing by vendor prior to close of event. Any disputed charges for service will not be considered without a written record on file prior to show close.
- 14 Signing this order vendor hereby agrees to all applicable terms of service.
